Reservations will be accepted in advance, please call the office to schedule your date.

The Birthday Party package includes:

- Two (2) hours for the birthday party (food, cake and presents) at the applicant's discretion.
- The Party Room with tables and chairs for guests.
- Unlimited access to the Exploration Discovery Center (*be aware that most likely the Center will be open to the public during your party time*).
- Group maximum is 20 guests (10 children maximum, 10 adults maximum).
- Children under the age of 18 years must be accompanied by an adult.

Rates

- Up to 10 children and 10 adults: \$200 for a two (2) hour party and play at the Exploration Discovery Center.
- Additional hour \$50

Down-Payment

- A 50% refundable down payment and signed contract are required to reserve your event.
- The balance is due upon arrival of 5 days prior to the event.

Cancellations

- Cancellations must be made fourteen (14) days prior to the event. Failure to do so will result in a \$25 administrative fee.
- SCFECC reserves the right to cancel any applicant's reservation within fourteen (14) days' notice due to a scheduling conflict or with no notice in the event of an emergency closure of the facility.

Food

- Applicants may bring their own food, drink and birthday cake, or purchase snacks from our Food Snack area.
- Everything must be cleaned up before departure and extra bags will be provided.
- No cooking and no alcohol beverages are permitted.

Decorations: Please bring your own decorations and we will work with you to the best of our ability to decorate the birthday space.
